May kindly see the property statement online received from Sri Apoorv Singh, Additional District & Sessions Judge, Agra regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), his gross income from salary, other income source and father death claim are 45,97,261/- (Rs.30,98,994/- from salary, Rs.6,52,335/- from other source, Rs.7,45,704/- from father death claim and Rs.1,00,228/- from father pension account closure) and total deductions/Savings/investments against, Deposits in saving bank account, NPS, GIS, Income Tax, PPF, Down-payment of car and Auto loan and Insurances are Rs.38,75,933/-. The balance of Rs.16,97,294/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.7,21,328/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2017-19 (2017-18 & 2018-19).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2015-17 (2015-16 & 2016-17) online against case id- P00024972021 (old case id-4629), and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 17.12.2021. As such, there is delay in submitting the same. In this regard officer verbatim: "I most humbly submit that I am posted as Chief Investigating Officer in Lokayukta Office, Uttar Pradesh, Lucknow since 17th August, 2020. I was supposed to submit my property-statement for Financial year 2015-17, 2017-19 & 2019-21, but I could not do so at the designated time.

Sir, I have submitted my property-statement for the financial year 2015-17 on 09.12.2021 and I am submitting my property-statement for financial year 2017-19 and 2019-21 forthwith. I apologize for the delay in submitting the required statement (I was transferred twice in April 2018 & August 2020 and suffered from Covid in the Pandemic, Most Importantly, my father passed away on 29th june 2018, I was busy in succession proceeding etc.). I could not submit the required property-statement in the stipulated time." (mentioned in enclosed application dated 17.12.2021).

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Apoorv Singh, Additional District & Sessions Judge, Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
