May kindly see the online property statements received from Sri Rajiv Kamal Pandey, Principal Judge, Family Court , Chandauli has submitted his movable and immovable property statements held the at time of entering i.e., of joining into U.P. Higher Judicial Service i.e., his joining date 19/08/2013 .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement held at the time of joining into judicial service just after joining into U. P. Higher Judicial Service. He has submitted the aforesaid statement firstly on 09-12-2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated the reason which is quoted herein below :

" I had joined the UPHJS service on 19/08/2013 and just after joining i went to JTRI for three month training. After completion of training I returned KUSHINAGAR in february 2013 and thereafter in mid March 2013 ,I went to Hon'ble HIGH COURT OF JUDICATURE AT ALLHABAD for CLASSIFICATION work for a month but that was extended on monthly basis for twelve months.It is further submitted that my records relating to my Mutual FUNDS holdings were misplaced and I have to take too much pain in collecting those data. In the meantime my marriage performed on 06/12/2014 ,thereafter when I return back to KUSHINAGAR in april 2015 I was assigned FAST TRACK COURT FOR OFFENCES AGAINST WOMEN which is new established Court and I had to undertake too much pressure to achieve quantum of work. Further after year 2015 my wife become pregnant but due to miscarriage and on 01/11/2016 my father died due to which my family atmosphere remain tensed .Further in march 2017 another set back occure due to another miscarriage to my wife and I had to take her extra care on Doctor's advice, AFTER transfer From kushinagar to Varanasi in may 2017 there were frequent shifting/change of courts and I had to take extra precaution to complete my quantum of work prescribed and also to seek medical advises to procure a child. My wife again pregnant in NOV2018 and i hd to take her extra care ,In july 2019 a daughter was born and due to my wife's condition i am busy in performing duties as father in my personal life .IN NOV 2020 I promoted as PRINCIPAL JUDGE FAMILY COURT CHANDAULI which is the only parent court having no additional court with apendancy of about 3000 cases and I was too busy in managing that court and to tke care of my second daughter who is born on 26 january 2021 and my aging mother . DUE TO ALL THE ABOVE REASONS I COULD NOT CONCENTRATE TO PREPARE AND SUBMIT MY PROPERTY STATEMENTS OF THE JOINING, AND FURTHER FOR THE FINANCIAL PERIODS 2013-15,2015-17,2017-19,2019-2021, IN DUE TIME FOR WHICH I AM TENDERING UNCONDITIONAL APOLOGY AND ALSO TO UNDERTAKE THAT NO SUCH MISTAKES SHALL BE COMIITTED IN FUTURE. "

May, therefore, if approved, movable & immovable property statement at the time of entering i.e., of joining into U.P. Higher Judicial service of Sri Rajiv Kamal Pandey , Principal Judge, Family Court ,Chandauli be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Chandauli Judgeship for His Lordship's kind perusal and orders.
