May kindly see the property statement online received from Sri Saurabh Kumar Verma, Secretary, Legal Services Authority, Bareilly, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-15 ( 2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2013-15 (2013-14 & 2014-15), Total income is Rs.15,39,209 /- (Gross income from salary is Rs. 12,56,261/-, matured amount of gratuity 2,82,948/-) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Home Loan instalments including interest on it, PPF & various policies amounts to 4,15,162 /- and the balance of his savings bank account(s) is enhanced by Rs.4,96,673/- this financial year from previous year's balance, total of which is Rs.911835/- . Thus, a sum of Rs.6,27,374/- was therefore available with him to meet out the household expenditure of his ownself only (as there were no other members in his family ) in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement related to joining which has been processed online & a separate note has been made on eservice-id no. P00000112020 (Old case id no. 4728) which has been placed before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Bareilly for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-14 & 2014-15 vide online dated 10/01/2020. As such, there is delay in submitting the same but reason for the delay is not given.

May, therefore, if approved, property statements for the financial years 2013-15 (2013-14 & 2014-15) of Sri Saurabh Kumar Verma, Secretary, Legal Services Authority, Bareilly be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Bareilly for His Lordship's kind perusal and orders?
