May kindly see the property statement received online from Sri Yogesh Kumar-II, Addl. District & Sessions Judge, Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2013-15 (2013-14 & 2014-15), the Gross income is Rs.38,38,985/- (Rs. 14,99,908/- from salary and Rs. 23,39,077/- from ancestral agricultural land sale) and total deductions/savings/investment against NPS, GIS, PPF and Income Tax is Rs.2,56,989/- and the balance of his savings bank account(s) is also increased by Rs.23,40,167/- in this financial year from previous year's balance, total of which is Rs.25,97,156/-. Thus, a sum of Rs.12,41,829/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2013-15 (2013-14 & 2014-15).

It is also pertinent to mention here that the officer's wife is a Judicial Officer whose annual gross income is Rs.6,55,481/- for the financial year 2013-15 (2013-14 & 2014-15). .

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2011-13 (2011-12 & 2012-13) online against Case Id : P00025802021 (Old Case Id : 4713) and the same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial year 2013-15 (2013-14 & 2014-15) vide online dated 10.12.2021. As such, there is delay in submitting the same for which the officer stated in the attachment dated 10.12.2021 of the property statement of financial year 2019-21(Case Id : P00038142021, Old Case Id : 5962), that (in his verbatim) *"I could not submit the required property statements in time because I continuously facing family problems since 2013, in year 2013 my father died in tragic situation, in year 2015 my mother diagnosed with cervix cancer 3rd stage, later on my newly born daughter diagnosed with tumour, operated at AIIMS, Delhi. Even now my mother health is critical and I am the only son to take care of her treatment etc. Meanwhile due to transers/packing my relevant documents were misplaced due to which I was unable to submit the required particulars in time. I deeply regret and submit my humble apology. I humbly request that my submission may kindly be placed before the Hon'ble court for kind and sympathetic consideration."*

May, therefore, if approved, property statements for the financial year 2013-15 (2013-14 & 2014-15) of Sri Yogesh Kumar-II, Addl. District & Sessions Judge, Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
