May kindly see the online property statement received from Sri Vishnu Kumar Sharma, District & Sessions Judge, Hamirpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, Total Gross slary is Rs.30,48,304/- and total deductions/ repayment/ savings/ investment (for both the financial years) against Insurance policies, PPF, GIS, NPS, Income Tax, wife's PPF a/c, RD, Sukanya Samriddhi Yojna and the balance of his savings bank account(s) has been enhanced for Rs.5,43,797/- this financial year from previous year's balance, total of which is Rs.18,64,114/-. Thus, a sum of Rs.11,84,190/-was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining which had already been seen by Hon'ble Mr. Justice Surendra Singh, the then Administrative Judge, Etah in the misc. file of the officer. Detailed offline note has been laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders, in the offline property statements of the financial years 2010-11, 2011-12, 2012-13 & 2013-14.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements for the financial years 2014-15 & 2015-16 firstly vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "delay in submission of property statements due to the health issues and problem of NPDR (Nonproliferative Diabetic Retinopathy) in his eyes", mentioned in reply dated 19.07.2024. May, therefore, if approved, property statements for the financial year 2014-15 & 2015-16 of Sri Vishnu Kumar Sharma, District & Sessions Judge, Hamirpur be laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders?
