May kindly see the property statement submitted online received from Sri Dr. Dinesh Chandra Shukla presently posted as Presiding Officer, Special Court (MP/MLA), Allahabad regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary and others sources is Rs. 32,34,579/- and total deductions/savings/investments against GPF, GIS, Income Tax, Insurances, MF (SIP), Advance amount for booking of flat is Rs. 20,69,538/- (including enhancement of Rs. 8,461/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 11,65,041/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Lecturer in GIC Meerut who transferred to Suraj pd. Govt Girls Inter college Jhansi. Her Gross salary is Rs. 8,83,406/- for FY 2017-18 and Rs 1025446 /- in FY 2018-19.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial years 2016-17 which has already seen offline by Hon'ble Mr. Justice Manoj Mishra, the then Administrative Judge, Meerut, Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e. 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 13.12.2021. As such, there is some delay in submitting the same from the part of the officer for which he has requested that due to judicial work and administrative duties he failed to submit property statement within time. He tender his apology to the Hon'ble court with folded hand that in future he will submit it timlely.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Dr. Dinesh Chandra Shukla presently posted as Presiding Officer, Special Court (MP/MLA), Allahabad be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
