May kindly see the property statement online received from Sri Saurabh Kumar Verma, Secretary, District Legal Services Authority, Bareilly, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below :

(1) In the financial years 2015-17 (2015-16 & 2016-17), Total income is Rs.15,06,444/- (Gross income from salary is Rs. 15,06,444/-) and total deductions related to GIS, NPS, Income Tax, Home Loan instalments, PPF & various policies amounts to 8,58,870 /- and the balance of his savings bank account(s) is decreased by Rs.3,04,942/- this financial year from previous year's balance, total of which is Rs.13,30,578/-. Thus, a sum of Rs.6,47,574/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2013-2015 (2013-2014 & 2014-2015) which has been processed online & a separate note has been made on eservice-id no. P00000112020 (Old case id 514) which has been placed before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Bareilly for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-17 (2015-16 & 2016-17) vide online dated 10/01/2020. As such, there is some delay in submitting the same but reason for the delay is not given.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Saurabh Kumar Verma, Secretary, District Legal Services Authority, Bareilly be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Bareilly for His Lordship's kind perusal and orders?
