In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary is Rs.34,50,502/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, Repayment of Home loan, Insurance and PPF is Rs.11,57,343/-. The balance of Rs.2,14,865/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.25,07,318/- (Rs.22,93,159/- from salary and Rs.2,14,865/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2016-18 (2016-17 & 2017-18) online against case id: P00003992023 and same has been processed before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Hamirpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay submitting the same. In this regard, officer stated that due to Covid-19 and health issue the officer had not submitted property-statement on time, officer has apologized for delay
