May kindly see the property statement online received from Sri Sudhakar Dubey, Additional District & Sessions Judge, Meerut regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), his gross income from salary is Rs.30,21,655/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, Mutual Fund, Sukanya Smariddhi Yojna, Insurances and Repayment of Loans are Rs.16,71,649/-. The balance of Rs.2,34,665/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,84,671/- (Rs.13,50,006/- from salary and Rs.2,34,665/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2017-19 (2017-18 & 2018-19).

In this connection, it is submitted that the Officer had already submitted his property statement for the financial years 2009-10 to 2016-17 in offline mode, which had already been seen by Hon'ble Mr. Justice B. Amit Sthalekar, the then Administrative Judge, Varanasi Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard officer's verbatim: " It is most humbly, submitted that pursuant to the aforesaid subject, I am hereby sending property statements for the financial years 2017-18 and 2018-19 for kind perusal of the Hon'ble Court. It pertinent to mention that I have already submitted earlier years property statements that due to bonafide mistake I could not sent the aforesaid property statements on time, I apologize for the same and assure that in future I will send the statements timely" (detailed application in attachment).

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Sudhakar Dubey, Additional District & Sessions Judge, Meerut be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
