May kindly see the property statements online received from Sri Vipin Kumar-II, Additional District & Sessions Judge (POCSO), Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), Total Gross income is Rs.34,27,171/- (income from salary Rs.31,50,171/- and income from S.B. a/c interest Rs.2,77,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, LIC policy, Income Tax and the balance of his savings bank account(s) is enhanced for Rs.9,94,659/- this financial year from previous year's balance, total of which is Rs.19,05,623/-. Thus, a sum of Rs.15,21,548/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Baghpat with the direction that "the officer should be cautioned to be careful in future and not to commit such mistake" in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) vide online dated 9.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has mentioned that he could not submit the same within time due to illness of his father and personal reasons, for which he regrets.

May, therefore, if approved, property statements for the financial year 2016-18 (2016-17 & 2017-18) of Sri Vipin Kumar-II, Additional District & Sessions Judge (POCSO), Mathura be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
