

## **Registrar (Judicial)(Budget)**

May kindly see the online application received from Smt. Sadhana Kumari Gupta, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly regarding submission of statements of movable and immovable properties for the financial years 2017-18 & 2018-19 in prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial year 2017-19 (2017-18 & 2018-19) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2017-19 (2017-18 & 2018-19), her gross income from salary is Rs.13,04,505/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Car loan, Insurances, and the balance of her savings bank account(s) is also enhanced for Rs.1,63,821/- this financial year from previous year's balance, total of which is Rs.9,50,556/- Thus, a sum of Rs.3,53,949/- was therefore available with him to meet out the household expenditure of her family consisting of three members.

It is pertinent to mention here that her husband is Chief Judicial Magistrate and his annual income for the financial year 2017-2018 is Rs. 7,59,026/- and 2018-2019 is Rs. 10,17,388/- .

In this connection, it is submitted that the officer has already submitted her property statements online for the financial year 2015-17 (2015-16 & 2016-17) and the same has been processed against case id.P00029532021 (Old Case Id : 5095) before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 09.12.2021. As such, there is delay in submitting the property statements from the part of the officer for which she has stated that due to work load & family reason, she could not submit the property statement in time for which she has apologized (Letter can be seen in attachment titled "delay pardon Letter")

May, if approved, the movable and immovable property statements for the financial year 2017-19 (2017-18 & 2018-19) of Smt. Sadhana Kumari Gupta, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
