May kindly see the property statement online received from Sri Vijay Kumar Gupta-II, Additional District & Sessions Judge/F.T.C., Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2015-16 & 2016-17, Total income from salary are Rs.22,48,279/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Insurance policies, PPF, Mutual Fund and the balance of his savings bank account(s) is enhanced for Rs.1,05,595/- this financial year from previous year's balance, total of which is Rs.9,71,292/-. Thus, a sum of Rs.12,76,987/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen offline by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Lucknow, in the misc. file of the officer and for the financial years 2009-10 & 2010-11, 2011-12 & 2012-13 and 2013-14 & 2014-15 which had been processed on e-service ID 5297, 5308 and 5220 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"The delay for submission of property statement is due to complete statements was not provided by his bank etc. within time, for which he tenders unconditional apology from Hon'ble Court."* mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2015-16 & 2016-17 of Sri Vijay Kumar Gupta-II, Additional District & Sessions Judge/F.T.C., Sultanpur be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgship for His Lordship's kind perusal and orders?
