May kindly see the property statement online received from Sri Yughul Shambhu, Judicial Magistrate, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary is Rs.14,02,101/and total deductions/Savings/investments against NPS, GIS, Income Tax and PPF is Rs.2,72,182/-. The balance of Rs.1,29,013/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.12,58,932/- (Rs.11,29,919 from salary and Rs.1,29,013 from saving bank account) was therefore available with him to meet out the household expenditure of himself in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement at the time of Joining into U.P. Judicial Service online against case id-P00008102020 (Old Case Id: 1665), which has been seen by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Etah.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: "It is therefore my humble request to accept the same. I could not submit the property statement on time due to workload and Covid-19 Pandemic. I tender my sincere apology for the same and request Hon'ble court to kindly forgive me. I shall be highly obliged."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Yughul Shambhu, Judicial Magistrate, Varanasi, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
