May kindly see the property statement submitted online received from Sri Hemendra Kumar Singh, Additional District & Sessions Judge, Hardoi, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2011-13 (2011-12 & 2012-13) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2011-13 (2011-12 & 2012-13) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

In the financial years 2011-13 (2011-12 & 2012-13), his gross income is Rs. 13,95,101/- total deductions/savings/investments against CPF, GIS, Income Tax, LIC Policies, RD, FD, NSC, PPF, repayment of car loan and the balance of his S.B.A/c has enhanced for Rs.27,875/- this financial years against the balance of previous year's, total of which is Rs.6,85,032/- . Thus a balance of Rs. 7,10,069/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements of the financial year 2009-11, which has already been processed before Hon'ble Mr. Justice Saurabh Shyam Shamsbery, Administrative Judge, Hardoi Judgeship on old case Id no.5221.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2011-13 (2011-12 & 2012-13) in its next financial year i.e.,2013-14 upto 31st March 2014. He has submitted movable and immovable property statements for the financial years 2011-13 (2011-12 & 2012-13) vide his application dated 10.12 2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer stated that due to bonafide mistake and ill health in some financial years, he could not send the aforesaid property statements on time. He apologizes for the same and assures that in future he will send the statements timely.

May, therefore, if approved, property statements for the financial years 2011-13 (2011-12 & 2012-13) of Sri Hemendra Kumar Singh, Additional District & Sessions Judge, Hardoi, be laid before Hon'ble Mr. Justice Saurabh Shyam Shamsbery, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
