In the financial year 2017-19 (2017-18 & 2018-19), Total income from salary is Rs.28,50,178/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, LIC policy and the balance of his savings bank account(s) is also enhanced for Rs.12,22,367/- this financial year from previous year's balance, total of which is Rs.21,80,887/-. Thus a sum of Rs.6,69,291/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both the financial years.

It is pertinent to mention here that his wife Smt. Arti Singh, Assistant primary teacher, income For-2017-18 Rs.39,048/-per month and For-2018-19 Rs.42,237/-per month.

In this connection, it is submitted that the officer has already submitted his property statements for financial years 2015-17 which is also seen offline by Hon'ble Mr. Justice Bachchoo Lal, the then Administrative Judge, Pratapgarh Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e. 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that he could not submit the same because of illness of his son and limited functioning of the Court due to Covid-19 Pandemic. He sincerely apologizes for the delay in this regard.
