May kindly see the property statement submitted online received from Sri Kamal Singh, Civil Judge (Senior Division), Ghaziabad regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), Total income from salary is Rs.33,91,702/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, Insurances and the balance of his savings bank account(s) is also enhanced for Rs.10,23,987/- this financial year from previous year's balance, total of which is Rs.23,32,903/-. Thus a sum of Rs.10,58,799/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both the financial years.

It is pertinent to mention here that his wife Smt. Arti Singh, Assistant primary teacher, income For-2019-20 Rs.46,619/-per month and For-2020-21 Rs.48,023/-per month.

In this connection, it is submitted that the officer has already submitted his property statements for financial years 2017-19 which is also processed online before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad Judgeship on e-service old case Id no.5252.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e. 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 10.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21( 2019-20 & 2020-21) of Sri Kamal Singh, Civil Judge (Senior Division), Ghaziabad be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
