May kindly see the property statement received online from Sri Meraj Ahmed, Additional District & Sessions Judge (POCSO), Lalitpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2015-17 (2015-16 & 2016-17), Gross salary is Rs.18,09,676/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, LIC and the balance of his savings bank account is also enhanced by Rs.6,28,092/- in this financial year from previous year's balance, total of which is Rs.10,86,834/-. Thus, a sum of Rs.7,22,842/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

In this connection, it is submitted that the Officer has submitted his property statements upto financial years 2013-15 and the same has been processed online against Case Id : P00014182021 before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. The officer firstly submitted the property statement for the financial year 2016-18 online on 09.12.21 but due to wrong block year, objection was raised and now he has submitted his movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) vide online dated 16.02.24. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that due to transfer in different districts and timely unavailability of bank details the same could not be sent within time and the officer tendered his regret and apology, as mentioned by the officer in his letter dated 16.02.2024.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Meraj Ahmed, Additional District & Sessions Judge (POCSO), Lalitpur be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
