

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Smt. Nidhi Shishodia, Chief Judicial Magistrate, Saharanpur, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2014-2016 (2014-15 & 2015-16) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2014-2016 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2014-2016 (2014-15 & 2015-16), the Gross income from salary is Rs. 7,57,164/- and total deductions/ repayment/ savings/ investment against GIS, SA, MA, ROA, PPF and Income Tax are Rs.1,46,360/- and the balance of her savings bank account is also enhanced by Rs. 12,526/- in this financial year from previous year's balance, total of which is Rs.1,58,886/-. Thus, a sum of Rs.5,98,278/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2014-2016 (2014-15 & 2015-16).

It is also pertinent to mention here that the Officer's husband is a Judicial Officer whose annual income is approx. Rs. 7,38,000/-.

In this connection, it is submitted that the officer has already submitted her property statement held at the time of joining, online against Case Id : P00030052021 (Old Case Id :5148) and the same has been processed before Hon'ble Mr. Justice Siddharth, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2014-2016 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. She has submitted movable and immovable property statements of the financial year 2014-2016 (2014-15 & 2015-16) vide online dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has given reason of delay in attachment dated 10.12.2021 (in her verbatim), as under:

***"It is humbly submitted that I could not furnish my property statement in due time because of unavoidable circumstances such as marriage, premature transfer, first pregnancy, workload, non availability of steno, second pregnancy etc. The delay was purely inadvertent and it is prayed to the Hon'ble Court that delay may kindly be condoned considering these circumstances."***

May, therefore, if approved, property statements for the financial year 2014-2016 (2014-15 & 2015-16) of Smt. Nidhi Shishodia, Chief Judicial Magistrate, Saharanpur, be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Saharanpur Judgship for His Lordship's kind perusal and orders?
