May kindly see the online application received from Smt. Sadhana Kumari Gupta, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly regarding submission of statements of movable and immovable properties for the financial year 2019-21 (2019-20 & 2020-21) in prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial year 2019-21 (2019-20 & 2020-21) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2019-21 (2019-20 & 2020-21), her gross income from salary is Rs.35,08,370/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Car loan, Insurances, and the balance of her savings bank account(s) is also enhanced for Rs.19,89,596/- this financial year from previous year's balance, total of which is Rs.34,20,021/- Thus, a sum of Rs.88,349/- was therefore available with her to meet out the household expenditure of her family consisting of three members.

It is pertinent to mention here that the Officer's husband, Saurabh Kumar Verma is also a Chief Judicial Magistrate and his annual income for financial years 2019-20 & 2020-21 are Rs 17,02,830/- & Rs. 14,96,487/- respectively.

In this connection, it is submitted that the officer has already submitted her property statements online for the financial year 2017-19 (2017-18 & 2018-19) which has been processed against case id : P00030882021 (Old Case Id : 5231) before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 vide online dated 09.12.2021. As such, there is no delay in submitting the aforesaid property statements.

May, if approved, the movable and immovable property statements for the financial year 2019-21 (2019-20 & 2020-21) of Smt. Sadhana Kumari Gupta, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgship for His Lordship's kind perusal and orders?
