May kindly see the property statement online received from Smt. Asha Rani Singh, Additional Principal Judge, Family Court, Hardoi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18). Gross income from salary is Rs.23,65,386/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF and Insurances is Rs.13,20,346/-. Thus, a sum of Rs.55,42,077 (Rs.10,45,040/- from salary and Rs.44,97,037/- from saving bank account) was therefore available with her to meet out the household expenditure of her family consisting three members in the both of the financial, the balance of her savings bank account(s) is also decreased by Rs.44,97,037/- in this financial year from previous year's balance.

It is pertinent mention here that Officer's husband (Government Service in the Department of Food & Civil Supply, UP Government) having annual income was Rs.2,71,769/- (F.Y. 2016-17) and 2,71,004(F.Y. 2017-18).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2014-16, which has been already seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Unnao in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that due to Covid guidelines and some time Court off during Covid period.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Smt. Asha Rani Singh, Additional Principal Judge, Family Court, Hardoi be laid before Hon'ble Mr. Justice Saurabh Shyam Shamsbery, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
