May kindly see the property statement online received from Sri Gyanendra Tripathi, Addl. District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his gross income from salary and allowances is Rs.32,42,414/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Insurances and Repayment of home loan is Rs.19,86,133/-. The balance of Rs.57,804/- has decreased from his saving bank A/cs against the balance of the previous year. Thus a sum of Rs.13,14,085/-(Rs.12,56,281/- from Salary and Rs.57,804/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent to mention here that Officer's wife's (Labour Enforcement Officer, Agra) annual income was Rs.11,04,000/- for the financial years 2019-20 & 2020-21..

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial years 2017-19 (2017-18 & 2018-19) Offline (Misc. file of the officer) and same has been processed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.12.2021. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Gyanendra Tripathi, Addl.
