In the financial years 2017-19 (2017-18 & 2018-19), his gross income is Rs. 24,85,713/- total deductions/savings/investments against CPF/NPS, GIS, Income Tax, LIC Policies, PPF, FD, donation and the balance of his S.B.A/c has enhanced for Rs.7,212/- this financial years against the balance of previous year's, total of which is Rs.6,16,919/-. Thus a balance of Rs. 18,68,794/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that wife of the officer Smt Minu Singh is working as Assistant Teacher in Primary School.

In this connection, it is submitted that the officer has already submitted his property statements of the financial year 2015-17, which has already been processed before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Hardoi Judgeship on old case Id no.5282.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e.,2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide his application dated 10.12 2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer stated that due to bonafide mistake and ill health in some financial years, he could not send the aforesaid property statements on time. He apologizes for the same and assures that in future he will send the statements timely.
