May kindly see the property statement received online from Smt. Swati Chandra, Secretary, District Legal Services Authority, Auraiya regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.17,96,742/- and total deductions/ repayment/ savings/ investment against GIS, ELSS Scheme/Funds and Income Tax are Rs.4,15,199/- and the balance of her savings bank account is also increased by Rs.1,49,059/- in this financial year from previous year's balance, total of which is Rs.5,64,258/-. Thus, a sum of Rs.12,32,484/- was therefore available with her to meet out the household expenditure of her family consisting of six members in the financial year 2017-2019 (2017-18 & 2018-19).

It is pertinent to mention here that Officer's husband Mr. Sanjay Kumar Singh is a Judicial Officer having annual income of Rs.15,00,000/- and her father-in-law have annual income of Rs.9.50 lakhs approx. from pension.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements at the time of joining into U. P. Judicial Service online against Case Id : P00002292021 (Old Case Id : 2221) and the same has been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Meerut Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 15.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has stated in the attachment dated 10.12.2021, that (in her verbatim) *"It is humbly submitted that my parents-in-law are living with me and my husband. My elder and only brother-in-law expired on 09-12-2015. Since the, my family and my parents-in-law are shattered and disturbed. My parents-in-law often get seriously ill and need to be hospitalized. I have been managing their daily chores and affairs. Under these circumstances, I missed to submit property statements on time. It is therefore, humbly requested to Hon'ble court to kindly grant me pardon for delay in submitting the property statements. I assure that I shall submit the property statement on time in the future. I shall be highly obliged for the mercy of Hon'ble court."*

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Smt. Swati Chandra, Secretary, District Legal Services Authority, Auraiya, be laid before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders?
