May kindly see the property statement received online from Sri Raghuvansh Mani Singh, Civil Judge (Senior Div.), Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross salary is Rs.32,37,271/- and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, SSA, Home loan and the balance of his savings bank account is enhanced by Rs.5,15,304/- in this financial year from previous year's balance, total of which is Rs.19,17,620/-. Thus, a sum of Rs.13,19,651/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years. It is pertinent to mention here that officer's wife is A.C.J.M. and her annual income is Rs.10,49,300/- and Rs. 10,21,539/- for the financial year 2019-20 & 2020-21, respectively, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2017-19 and the same has been processed online against Case Id : P00031542021 before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 11.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Raghuvansh Mani Singh, Civil Judge (Senior Div.), Muzaffarnagar be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgship for His Lordship's kind perusal and orders?
