(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross salary is Rs.32,37,271/- and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, SSA, Home loan and the balance of his savings bank account is enhanced by Rs.5,15,304/- in this financial year from previous year's balance, total of which is Rs.19,17,620/-. Thus, a sum of Rs.13,19,651/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years. It is pertinent to mention here that officer's wife is A.C.J.M. and her annual income is Rs.10,49,300/- and Rs. 10,21,539/- for the financial year 2019-20 & 2020-21, respectively, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2017-19 and the same has been processed online against Case Id: P00031542021 before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 11.12.2021. As such, there is no delay in submitting the same.
