May kindly see the property statement submitted online received from Sri Rajiv Kamal Pandey, Principal Judge, Family Court, Chandauli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), his Total income from salary & other sources is Rs.31,09,570/- (income from salary with allowances is Rs.29,61,003/-, income from redeemed amount of mutual funds is Rs. 92,435/-, income from maturity amount of LIC Policy is Rs.39,757/- and income from bank Interests is Rs.16,375/-) and total deductions/savings/investments against IT, GIS, NPS, Insurance Policy and PPF are Rs.12,11,549/- . Thus a sum of Rs.18,98,021/- was therefore available with him to meet out the household expenditure of his in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.7,79,573/- this financial year from previous year's balance.

It is pertinent to mention here that his father Sri Shiv Kailash Pandey is retired District Judge (Govt. Pensioner, died on 1.11.16), monthly income Rs. 78,000/-(till death), his mother Smt. Meera Pandey is family pensioner (since 1.11.16) monthly income is Rs. 65,000/- and his wife Smt. Shilpi Shukla is assistant teacher in govt. primary school, Kushinagar, monthly income is Rs. 30,000/-.

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial years 2013-15 which is also processed online before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Chandauli Judgeship on old case ID no-5278.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer and he has stated that the delay occurred due to officer's marriage, wife's miscarriage and medical advices to procure a child, taking care of his aging mother and too much pressure of work, he could not submit the same in time. For which he apologizes and ensure that no such mistake shall be committed in future.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Rajiv Kamal Pandey, Principal Judge, Family Court, Chandauli, be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Chandauli for His Lordship's kind perusal and orders?
