May kindly see the property statement online received from Smt. Asha Rani Singh, Additional Principal Judge, Family Court, Hardoi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20). Gross income from salary is Rs.30,30,119/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF, Insurances and the balance of her savings bank account(s) is also enhanced by Rs.2,65,613/- in this financial year from previous year's balance, total of which is Rs.20,65,035/-. Thus, a sum of Rs.9,65,084/- was therefore available with her to meet out the household expenditure of her family consisting three members in the both of the financial.

It is pertinent mention here that Officer's husband (Government Service in the Department of Food & Civil Supply, UP Government) having annual income was Rs.2,96,059/- (F.Y. 2018-19) and 3,32,489 (F.Y. 2019-20).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2016-18 (2016-17 & 2017-18) online against case id- P00031422021 (old case id 5286) and same has been processed before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Hardoi for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Asha Rani Singh, Additional Principal Judge, Family Court, Hardoi be laid before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
