May kindly see the property statement submitted online dated 10.12.2021 received from Sri Ranjeet Kumar, Additional District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2016-18 (2016-17 & 2017-18), income from salary & other sources is Rs.27,45,040/- (income from salary Rs.25,11,294/- and income from maturity amount of NSC Rs.2,33,746/-), and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, Insurance Policy, PPF, repayment of personal loan and the balance of his savings bank account(s) is also enhanced for Rs.1,47,641/- this financial year from previous year's balance, total of which is Rs.16,41,695/-. Thus, a sum of Rs.11,03,345/- was therefore available with him to meet out the household expenditure of his family consisting of three members for both the financial years 2016-18 (2016-17 & 2017-18).

In this connection it is submitted that, he has submitted his property statement upto the financial year 2014-16, which has already been processed before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad, on old case Id no-5317.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. has submitted movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that due to busy in work, he could not prepare the property statement on time, for which he sincerely apologizes. He also ensure that he will submit the same on time in future.

May, therefore, if approved, property statements for the financial year 2016-18 (2016-17 & 2017-18) of Sri Ranjeet Kumar, Additional District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
