May kindly see the property statement online received from Sri Chandroday Kumar, District & Sessions Judge, Lalitpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Total income is Rs.37,89,680/- (income from salary Rs.35,44,680/- and Rs.2,45,000/- borrow from mother in law) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, Insurances and repayment of Housing loan, total of which is Rs.28,64,409/-. Thus, a sum of Rs.9,25,271/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. And the balance of his savings bank account(s) is reduced by Rs.1,28,686/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements of the financial year 2014-16 which is already been processed online before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Lalitpur for His Lordship's kind perusal and orders on old case Id no-5318.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 10.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Chandroday Kumar, District & Sessions Judge, Lalitpur be laid before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Lalitpur for His Lordship's kind perusal and orders?
