May kindly see the property statement submitted online received from Sri Anil Kumar XII, Chief Judicial Magistrate, Shravasti at Bhinga regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary is Rs. 32,66,171/- and total deductions/savings/investments against GPF, GIS, Income Tax, Insurances policy and the balance of his Saving bank A/c is enhanced for Rs. 18,34,869/- this financial year from previous year's balance, total of which is Rs. 28,41,283/-. Thus a sum of Rs. 4,24,888/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his wife earned Rs. 3,01,983 /- and Rs. 3,42,010/- from LIC Commission & Tution for the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2016-18 (2016-17 & 2017-18) which is processed online and same has been approved by Hon'ble Ms. Justice Subhash Chandra Sharma, Administrative Judge, Shravasti Judgeship in Case Id : P00008312020 (Old Case Id : 1691).

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-2021 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, Officer has stated that due to unfavourable medical condition of family member, unable to collect financial information to complete the form and due to Covid-19 Period & excessive Judiciary work load.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Anil Kumar XII, Chief Judicial Magistrate, Shravasti at Bhinga be laid before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Shravasti for His Lordship's kind perusal and order?
