May kindly see the property statement received online from Sri Bateshwar Kumar, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2015-2017 (2015-16 & 2016-17), the Gross income from salary is Rs.14,62,668/- and total deductions/savings/investment against GIS, NPS, PPF, Car Loan repayments including down payments and Income Tax is Rs.7,72,127/- and the balance of his savings bank account(s) is also decreased by Rs.14,777/- in this financial year from previous year's balance. Thus, a sum of Rs.7,05,318/- (Rs.6,90,541/- from Salary and Rs.14,777/- from SB account) was therefore available with him to meet out the household expenditure of his family consisting six members of the financial year 2015-2017 (2015-16 & 2016-17).

It is pertinent to mention here that Officer's father is a farmer having annual income of Rs.60,000/-.

In this connection, it is submitted that the Officer has already submitted his property statement at the time of joining into U.P. Judicial Service, offline and the same has been seen by Hon'ble Mr. Justice Munishwar Nath Bhandari, the then Administrative Judge, Firozabad Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) vide online dated 11.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated that (in his verbatim) "*Respected Sir, Please condone delay*", in the remark column.

May, therefore, if approved, property statements for the financial year 2015-2017 (2015-16 & 2016-17) of Sri Bateshwar Kumar, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
