May kindly see the online property statements received from Sri Ashok Kumar-IX, Principal Judge, Family Court, Farrukhabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.36,17,569/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, Home Loan, NPS, Insurance policies and PPF a/c are Rs.14,47,941/-. Thus, a sum of Rs.21,69,628/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.5,27,902/- this financial year from previous year's balance.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2013-14, which has already been seen by Hon'ble Mr. Justice Ashok Pal Singh, the then Administrative Judge, Basti, placed in the misc. file of the officer. And property statement of the financial years 2014-16 & 2016-18, detailed notes have been laid online before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad Judgeship for His Lordship's kind perusal and orders on eService ID P00004282023 & P00004292023.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 12.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"required papers related to property statements get messed up due to his transfer from Etah Judgeship to Agra Judgeship on the basis of medical condition and MOD amount in his salary account has not being cleared by the Bank. Therefore, he has inadvertently could not submit the property statements within time"*, mentioned in attachment letter dated 10.12.2021.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Ashok Kumar-IX, Principal Judge, Family Court, Farrukhabad be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad Judgeship for His Lordship's kind perusal and orders?
