May kindly see the property statements online received from Sri Abhishek Kumar Chaturvedi, Additional District & Sessions Judge/ F.T.C., Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial year 2017-18 & 2018-19, Total Gross income is Rs.37,20,380/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, car loan and the balance of his savings bank account(s) is enhanced for Rs.4,97,651/- this financial year from previous year's balance, total of which is Rs.11,40,758. Thus, a sum of Rs.25,79,622/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that he has already submitted his property statements upto the financial year 2016-17, which has already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Aligarh, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-18 & 2018-19 firstly vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "due to Covid-19 pandemic, he was unable to get necessary documentation from Lucknow to prepare his property statement and due to oversight he was unable to furnish the statement within time, which may kindly be condoned" mentioned in remark column of the movable proforma.

May, therefore, if approved, property statements for the financial years 2017-18 & 2018-19 of Sri Abhishek Kumar Chaturvedi, Additional District & Sessions Judge/ F.T.C., Ramabai Nagar be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
