May kindly see the property statement online received from Smt. Shagun Panwar, Additional Principal Judge, Family Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2017-19 (2017-18 & 2018-19), her gross income from salary is Rs.29,08,133/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, PPF and FD is Rs.8,36,159/-. The balance of Rs.2,17,406/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.22,89,380/- (Rs.22,71,974/- from salary and Rs.2,17,406 from saving bank account) was therefore available with her to meet out the household expenditure of her family consisting five members in the financial years 2017-19 (2017-18 & 2018-19).

It is pertinent mention here that's Officer's Husband (Judicial Officer) having annual income was Rs.16,97,388/- for the financial years 2017-19 (2017-18 & 2018-19).

In this connection, it is submitted that the Officer has already submitted her property statement up to the the financial years 2015-17 (2015-16 & 2016-17) online against case id-P00032472021 (old case id-5391) and same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide dated 10.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer Verbatim:" I am submitting the required particulars of my movable and immovable properties for the financial years 2011-13, 2013-15, 2015-17, 2017-19 and 2019-21. I could not submit the required property statements in time because of family problems and upbringing of newly born two daughters. Meanwhile due to transfers/packing my relevant documents were misplaced due to which I was unable to submit the required particulars in time. It is pertinent to mention that during the above financial years I have not acquired any immovable or movable property except Wagon-R Car, intimation of which is already sent to the Honorable Court vide letter 1308/I dated 14.08.2013 and my single source of income is salary. I deeply regret for delay and submit my humble apology. I humbly request that my submission may kindly be placed before the Honorable Court for kind and sympathetic consideration" (Reason for delay mentioned in application of financial years 2019-21 which is submitted by the officer online against case id-P00032812021 ,Old Case Id : 5425).

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Smt. Shagun Panwar, Additional Principal Judge, Family Court, Kanpur Nagar be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
