May kindly see the property statement online received from Sri Sushil Kumar-III, Additional District & Sessions Judge, Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2010-12 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2010-12 (2010-11 & 2011-12) Gross income from salary and other sources Rs.18,30,085/-(income from salary is Rs.18,20,756/- and income from S.B. a/c interest Rs.9,329/-) and total deductions/savings/ investment against CPF, GIS, Income Tax, PPF, NSC, Insurance policy, repayment of loan and the balance of his savings bank account(s) is also increased by Rs.3,61,595/- in this financial year from previous year's balance, total of which is Rs.10,61,776/-. Thus, a sum of Rs.7,68,309/- was therefore available with him to meet out the household expenditure of his family consisting of three member in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement upto the financial year 2009-10 offline and same has been seen by Hon'ble Mr. Justice Vimlesh Kumar Shukla, the then Administrative Judge, Hathras in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements of the financial year 2010-12 (2010-11 & 2011-12) vide online dated 10.12.2021. As such, there is no delay in submitting the same from part of the officer. In this regard, office has mentioned that he had submitted his property statement in the calendar year 2010, thereafter completing the normal tenure in the District he was transferred to another District in the month of april 2011. Because of shifting of household goods on annual transfer his papers such as bank account passbook etc. got missing in the coming years due to excess workload and missing of papers he could not submit property statement on time. He also requested to condone the delay in filing of his property statements.

May, therefore, if approved, property statements for the financial years 2010-12 (2010-11 & 2011-12) of Sri Sushil Kumar-III, Additional District & Sessions Judge, Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat for His Lordship's kind perusal and orders
