In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2019-21 (2019-20 & 2020-21), her gross income from salary is Rs.38,15,938/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Repayment of home loan & advance and Repayment of car loan are Rs.32,60,324/-. The balance of Rs.9,04,345/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,59,959/- (Rs.5,55,614/- from salary and Rs.9,04,345/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent mention here that's Officer's Husband (Business of handicraft) having annual income of Rs.10,41,450/- for the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2017-19 (2017-18 & 2018-19) online against case id-P00037472021 (old case id-5895) and same has been processed before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She had submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.12.2021 on eServicesJo portal. As such, there is no delay in submitting the same.
