May kindly see the property statement online received from Smt. In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2019-21 (2019-20 & 2020-21), her gross income from salary is Rs.36,84,514/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, PPF and FD is Rs.15,68,715/-. The balance of Rs.15,702/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.21,31,501/- (Rs.21,15,799/- from salary and Rs.15,702 from saving bank account) was therefore available with her to meet out the household expenditure of her family consisting five members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent mention here that's Officer's Husband (Judicial Officer) having annual income was Rs.19,01,830/- for the financial years 2019-21 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted her property statement up to the the financial years 2017-19 (2017-18 & 2018-19) online against case id-P00032612021 (old case id-5405) and same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide dated 11.12.2021 on eServicesJo portal. As such, there is no delay in submitting the same.
