May kindly see the property statement online received from Sri Angad Prasad-II, Special Judge (Essential Commodities Act), Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2016-17 & 2017-18, income from salary is Rs.31,35,002/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Insurance policies, Car loan, Personal loan, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.21,994/- this financial year from previous year's balance, total of which is Rs.15,55,993/-. Thus, a sum of Rs.15,79,009/- was therefore available with him to meet out the household expenditure of his family consisting six members in both the financial years.

It is pertinent to mention here that his daughter is in NIIT, Gurgaon having annual income of Rs.2,00,000/- approx.

In this connection it is submitted that the officer has also submitted his property statement upto the financial year 2013-14, which has already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Rampur and the financial years 2014-15 & 2015-16, which has been processed presently online & separate office note has already been submitted for order on separate ID no.5424.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial year 2016-17 & 2017-18 firstly vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to over load of judicial work, he was not submitted the property statements up to March 2019 for which he has apologized, mentioned in his reply dated 21.01.2022.

May, therefore, if approved, property statements for the financial years 2016-17 & 2017-18 of Sri Angad Prasad-II, Special Judge (Essential Commodities Act), Bareilly be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
