May kindly see the online property statements received from Sri Ram Pyare, Presiding Officer, Commercial Court, Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, total Gross salary is Rs.49,89,906/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, loans, PPF, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.5,58,171/- this financial year from previous year's balance, total of which is Rs.32,55,930/-. Thus, a sum of Rs.17,33,976/- was therefore available with him to meet out the household expenditure of his family consisting six members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement for the calendar year 2003 which has already been seen by Hon'ble Mr. Justice S.N.Srivastava, the then Administrative Judge, Moradabad, placed in the misc. file of the officer. For the financial years 2004-05 to 2013-14, detailed offline note has been submitted before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Mirzapur Judgeship for His Lordship's kind perusal and orders. And of the financial years 2014-16 & 2016-18 have been processed & separate notes have made on eService-id no. 4909 & 5472 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"due to certain unavoidable reasons and due to misplacement of certain bank accounts and loan related documents, the same could not be sent earlier, for which he conveys his sincere apologies and undertakes to adhere to timely submissions of the same in the near future"*, mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Ram Pyare, Presiding Officer, Commercial Court, Gorakhpur be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
