May kindly see the property statement online received from Sri Nitendra Kumar, Registrar (J)(Accounts), High Court Lucknow Bench, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-2019 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-2019 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-2019 & 2019-20), his gross income from salary is Rs.34,46,661/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, R.D., NSC, PPF and Mutual Funds (SIP) are Rs.18,73,140/-. The balance of Rs.3,82,968/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,28,479/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2018-20 (2018-2019 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial years 2016-18 (2016-17 & 2017-18) online against case id: P00033022021 (old case id-5446) and same has been processed before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-2019 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-2019 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: "... I have to humbly submit that, I am submitting my property statements for the financial years 2018-2019 and 2019-20, unwittingly which could not be sent on time.."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-2019 & 2019-20) of Sri Nitendra Kumar, Registrar (J)(Accounts), High Court Lucknow Bench, Lucknow be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
