May kindly see the property statement submitted online received from Sushri Vibha Dhama, Judicial Megistrate, Muzaffar Nagar, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year, 2018-20 (2018-19 & 2019-20), her Total income from salary is Rs.16,31,354/- and total deductions/savings/investments against NPS, GIS, Income Tax, NSC and the balance of her savings bank account(s) is also enhanced for Rs.2,46,947/- this financial year from previous year's balance, total of which is Rs.6,23,732/-. Thus a sum of Rs.10,07,622/- was therefore available with her to meet out the household expenditure of her family consisting of two members in both the financial years.

It is pertinent to mention here that her husband Mr. Gagan Deep, Civil Judge (Jr. Div./F.T.C.), Muzaffarnagar, monthly income from salary Rs. 84388/- (Married on 04.02.2020).

In this connection, it is submitted that the officer has already submitted his property statements online at the time of joining which is processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Muzaffar Nagar for kind perusal and order on old case Id no.342.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide her application dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer. For which she has not given any reason for delay submission.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sushri Vibha Dhama, Judicial Megistrate, Muzaffar Nagar be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Muzaffar Nagar for Her Lordship's kind perusal and orders?
