In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Total income from salary is Rs.9,26,528/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NSC and the balance of his savings bank account(s) is enhanced by Rs.1,83,685/- this financial year from previous year's balance, total of which is Rs.3,79,063/-. Thus, a sum of Rs.5,47,465/- was available with his to meet out the household expenditure of his family consisting of two members in both of the financial years.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 09.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer is seeking unconditional appology for not submitting property statement on time. He also condoned the delay in submitting property statement.
