

## **Registrar(J)(Budget)**

May kindly see the online reply dated 27/10/2023 received from Sri Vivek Yadav, Addl. Civil Judge (Junior Div.), Saidpur-Ghazipur, in compliance of order of Hon'ble Mr. Justice Dinesh Kumar Singh, the then Administrative Judge, Ghazipur Judgeship in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Ghazipur through detailed office note dated 23/05/2023, on which His Lordship has been pleased to pass the following order dated 11/07/2023:

**"It appears that there is delay in submission of the property statement and the officer has not even cared to explain the same.**

**Submission of property statement is not a mere farce formality, but is a predominant requirement of Government Servants Conduct Rules.**

**It is being noticed that certain Judicial Officers do not adhere to the time scheme as provided in the Circular Letter and are sending their property statements in a very casual manner.**

**Let him ask to explain the delay and the reasons hereof within two weeks.**

**Office shall forthwith place the property statements of the officer after receipt of his explanation."**

The order of the Hon'ble Court had been communicated to the officer concerned on 18/07/2023.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated that, in his verbatim as under:

*"Most respectfully submitted that the undersigned is asked to explain the delay caused in submission of property statement at the time of joining i.e. 16.12.2019.*

*Further, most respectfully submitted that the undrsigned was new to the service and less familiar to the norms regarding the submission of property statement at the time of joining which caused the unnecessary delay in timely submission of property statement.*

*so, it is most respectfully prayed that kindly condone the delay caused in submitting the property statement. I shall be highly obliged to you."*

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement held at the time of joining into judicial service just after joining into U. P. Judicial Service. His joining date is 16/12/2019. He has submitted the aforesaid statement firstly on 13/12/2021. As such, there is delay in submitting aforesaid property statement from the part of the officer. In this regard, officer has given the reason for delay and compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Hon'ble Court in the matter, furnished by Sri Vivek Yadav, Addl. Civil Judge (Junior Div.), Saidpur-Ghazipur, be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders?
