May kindly see the property statement online received from Sri Deepak Nath Saraswati, Addl. Civil Judge (Senior Division)/ACJM. Gorakhpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Total income is Rs.8,77,990/- (Gross income from salary ) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, LIC and the balance of his savings bank account(s) is enhanced by Rs.1,27,284/- this financial year from previous year's balance, total of which is Rs.2,45,863/-. Thus, a sum of Rs.6,32,127/- was available with his to meet out the household expenditure of his family consisting of two members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statements at the time of entering into judicial service which is currently processed online & a separate note has been made on Case Id: P00033702021 (Old Case Id:5515) and has been moved before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 10.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that he could not submit the property statement in time due to Corona pandemic and unawareness. Also, he has apolised for the same.
