May kindly see the property statement online received from Smt. Anamika Singh, Additional Civil Judge (Junior Division), Sitapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.15,22,776/- and total deductions/repayment/ savings/ investment against GIS, NPS, Income Tax, LIC Policy and the balance of her savings bank account(s) is enhanced by Rs.49,710/- this financial year from previous year's balance, total of which is Rs.3,52,943/-. Thus, a sum of Rs.11,69,833/- was available with her to meet out the household expenditure of her family consisting of two members in both of the financial years.

It is pertinent to mention here that her husband Sri Abhinav Srivastava is Additional Civil Judge (Jr. Div.), Kanpur Nagar (currently posted as Metropolitan Magistrate at Kanpur Nagar), gross monthly salary- Rs. 91,429/-.

In this connection, it is submitted that the Officer has already submitted her property statements of at the time of joining online and same has been processed before the Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Sitapur on old case Id no-4396.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As, there is delay in submitting the same for which officer has stated that due to inadvertence and some family problems during the corona period, she was unable to submit her property statement in due time.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Anamika Singh, Additional Civil Judge (Junior Division), Sitapur be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Sitapur for His Lordship's kind perusal and orders?
