May kindly see the property statement online received from Sri Shrikrishna Chandra Singh, Additional District & Sessions Judge, Barabanki regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his gross income from salary and maturity of RD are Rs.45,54,430/- (Rs.41,81,165/- from salary and Rs.3,73,265/- from maturity of RD) and total deductions/Savings/investments against, NPS, GIS, Income Tax, LIC, RD, Repayment of Home Ioan & Down-payment are Rs.26,18,983/- .The balance of Rs.28,290/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.19,63,737/- (Rs.19,35,447/- from salary and Rs.28,290/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent to mention here that officer's wife (Advocate) has an annual income of Rs.3,60,000/- for the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2017-19 (2017-18 & 2018-19) online against case id-P00031492021 (old case id:5293) and same has been processed before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Shrikrishna Chandra Singh, Additional District & Sessions Judge, Barabanki be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
