May kindly see the property statement online received from Sri Deepak Nath Saraswati, Addl. Civil Judge (Senior Division)/ACJM. Gorakhpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Total income from Salary is Rs.23,88,018/- and total deductions/ repayment/ savings/ investment against NPS,GIS, IT, LIC , Sukanya Samridhi Yojana is Rs.5,50,974. Thus, a sum of Rs.18,37,044/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years. And the balance of his savings bank account(s) is also decreased for Rs.54,350/- this financial year from previous year's balance

In this connection, it is submitted that the officer has already submitted his property statements at the time of entering into judicial service and of the financial years 2016-18 which are currently processed online & separate notes has been made on Case Id : P00033702021 (Old Case Id :5515) And Case Id : P00033732021 (Old Case Id : 5518) and has been moved before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that he could not submit the property statement in time due to Corona pandemic and unawareness. Also, he has apolised for the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Deepak Nath Saraswati, Addl. Civil Judge (Senior Division)/ACJM. Gorakhpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders?
