Thus, a sum of Rs.18,37,044/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years. And the balance of his savings bank account(s) is also decreased for Rs.54,350/- this financial year from previous year's balance

In this connection, it is submitted that the officer has already submitted his property statements at the time of entering into judicial service and of the financial years 2016-18 which are currently processed online & separate notes has been made on Case Id: P00033702021 (Old Case Id: 5515) And Case Id: P00033732021 (Old Case Id: 5518) and has been moved before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that he could not submit the property statement in time due to Corona pandemic and unawareness. Also, he has apolised for the same.
