May kindly see the property statement submitted online received from Dr. Devendra Singh Fauzdar, Addl. Civil Judge (Sr.Div.)/ACJM., Muzaffar Nagar regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), Total income from salary is Rs.27,61,106/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF and the balance of his savings bank account(s) is also enhanced for Rs.13,057/- this financial year from previous year's balance, total of which is Rs.12,47,146/-. Thus a sum of Rs.15,13,960/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that officer's wife Mrs. Jasmine, Group B Gazetted Officer (UP), income- Rs 911266/- per annum.

In this connection, it is submitted that the officer has already submitted his property statements for financial years 2017-19 which is also seen online by Hon'ble Mr. Justice Alok Singh, the then Administrative Judge, Budaun Judgeship on e-service old case Id no.1457.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e. 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide his application dated 09.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21( 2019-20 & 2020-21) of Dr. Devendra Singh Fauzdar, Addl.
