May kindly see the property statement submitted online received from Smt. Monika, Civil Judge (Senior Div.), Amroha, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year, 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.17,88,582/and total deductions/savings/investments against NPS, GIS, Income Tax, SIP, PPF, repayment of car loan and the balance of her savings bank account(s) is also enhanced for Rs.1,33,009/- this financial year from previous year's balance, total of which is Rs.5,81,731/-. Thus a sum of Rs.12,06,851/- was therefore available with her to meet out the household expenditure of herelf in both the financial years.

It is pertinent to mention here that her father Mr. Om Prakash is a pensioner (Pension Rs.30,000/-) and her brother Mr. Abhijeet Kumar is working in HPCL, Pune having gross salary Rs.60,000/-.

In this connection, it is submitted that the officer has already submitted his property statements offline at the time of joining which had already been seen by Hon'ble Mr. Justice Shashi Kumar Gupta, the then Administrative Judge, Pratapgarh in Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide her application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard she has mentioned that she could not send the required particulars of property in time because of the limited functioning of the Court due to Corona pandemic. For which she sincerely apologizes of the delay in this regard.
